

TERMS AND CONDITIONS

FOR

Promotional Offer: 20% Discount for 6 Months on the Unlimited Plan Only

(Valid from 16 July 2025 – 09 September 2025)

(New Superdrug Mobile Customers Only)

- 1. **Promoter**: Superdrug Head Office, trading as Superdrug Mobile (company no. 00807043), registered at 51 Sydenham Road, Croydon, Surrey, CRO 2EU, United Kingdom.
- 2. **Promotional Offer**: New Superdrug customers will receive a 20% discount code off the full price of the Superdrug Mobile monthly SIM-only unlimited plan, which includes unlimited data, calls, and texts (the "**Eligible Plan**"), for six consecutive months when the **Eligible Plan** is purchased during the Promotion Period (the "**Promotional Offer**"). Under this **Promotional Offer**, the standard price of £20 per month will be reduced to £16 per month for six (6) consecutive months (the "**Promotional Price**").
- 3. **Promotion Period:** The Promotional Offer is valid from 00:00 GMT on 16 July 2025 to 23:59 GMT on 09 September 2025 (the "**Promotion Period**"), but may be withdrawn, amended, or extended at any time and without notice (see Section 14 regarding variations to these terms and conditions).
- 4. **Eligibility**: To be eligible for the Promotion Offer, you must:
- a. be a new Superdrug Mobile customer, resident in the UK, and aged 16 or over to have an account.
- b. purchases the **Eligible Plan** instore, online via <u>superdrugmobile.com</u> or <u>Superdrug.com</u> during the **Promotion Period**; and
- c. Activate your SIM online via Superdrug Mobile's website by 23:59 GMT on 30 September 2025 using the code **E82025**
- 5. Eligible Customers will receive the **Promotional Price** from the date they activate their SIM online, provided they have followed all steps outlined in Section four (4).
- 6. **General Requirements:** Customers must also comply with the <u>Superdrug Mobile Terms and Conditions</u> in addition to these promotional terms.
- 7. The **Promotional Price** is valid for a maximum of six (6) consecutive months on the **Eligible Plan**, after which the standard monthly plan price of £20 will apply. To maintain the **Promotional Price** throughout this period, **Eligible Customers** must:



- a. either enables auto-renewal on their account or manually renew the Eligible Plan within 12 hours of the end of their monthly billing cycle; and
- b. remains subscribed to the Eligible Plan continuously for the six-month promotional period.
- 8. This **Promotional Offer** is only available while Superdrug Mobile continues to offer the **Eligible Plan** in its current form. Superdrug Mobile reserves the right to withdraw or modify the **Eligible Plan** at its sole discretion.
- 9. **Change of Plan**: If you switch to another plan or experience a break in your subscription at any point (e.g. by failing to auto-renew or renew manually within 12 hours of your plan ending), you will no longer be eligible for the **Promotional Offer**. You will only receive the **Promotional Price** for the months prior to the break or change.
- 10. The **Promotional Price** applies only to the monthly cost of the **Eligible Plan** and excludes any other charges, including but not limited to: out-of-bundle usage, additional services, administrative fees, or reconnection charges.
