

## <u>TERMS AND CONDITIONS</u> <u>FOR</u> <u>Superdrug Mobile Black Friday Promotional Offer</u> (valid between 6 November 2024 – 3 December 2024)

1. **Promoter**: Superdrug Stores plc, trading as Superdrug Mobile, (company no. 00807043) registered at 51 Sydenham Road, Croydon, Surrey, CR0 2EU, United Kingdom.

2. **Promotional Offer**: Save 20% off the full price of a Superdrug Mobile monthly SIM only plan of unlimited data, unlimited calls and texts (the "**Eligible Plan**") (the "**Promotional Offer**") for twelve months when you purchase the Eligible Plan during the Promotion Period. Under this Promotional Offer, the standard plan price of £20 per month will be reduced to £16 per month for twelve consecutive months on the Eligible Plan (the "**Promotional Price**").

3. Dates: The Promotional Offer will run from 00:00 GMT 6 November 2024 - 23:59 GMT 3 December 2024 (the "**Promotion Period**"), but may be withdrawn, amended or extended, at any time and without notice (see Section 14 below regarding variations to these terms and conditions).

b. purchase the Eligible Plan online on Superdrug Mobile's website (<u>Home | Superdrug Mobile</u>) during the Promotion Period using the code BF2024, or purchase a new Superdrug Mobile SIM Card either instore or online at Superdrug.com and upgrade it to the Eligible Plan; and

c. activate your SIM online on Superdrug Mobile's website by 23:59 GMT 3 December 2024. Please note that if you have already purchased a new Superdrug Mobile SIM Card either instore or online at Superdrug.com you will need to enter the code BF2024 at activation.

5. New Superdrug Mobile Customers will benefit from the Promotional Price with effect from activation of their SIM online on Superdrug Mobile's website once they follow the steps set out in Section 4 above.

6. You must comply with the Terms and Conditions for using Superdrug Mobile (<u>https://www.superdrugmobile.com/register/terms</u>) and follow the promotion steps set out in these terms and conditions.

7. The Promotional Price is available for a maximum of 12 (twelve) consecutive months on the Eligible Plan after which point your plan price will revert back to the standard price of £20 per month.
