

## TERMS AND CONDITIONS FOR

## Promotion Offer of 30GB data (unlimited calls and texts) plan with an additional 60GB data (90GB in total) (valid between 14 August 2024 – 10 September 2024)

- 1. **Promoter**: Superdrug Stores plc, trading as Superdrug Mobile, (company no. 00807043) registered at 51 Sydenham Road, Croydon, Surrey, CR0 2EU, United Kingdom.
- 2. **Promotion Offer**: Superdrug Mobile 60GB Data, unlimited calls and texts Plan OFFER (the "**Promotion Offer**") applies to the current Superdrug Mobile 1-month 30GB Data, unlimited calls and texts (the "**Eligible Plan**") purchased within the Promotion Period. Under this Promotion Offer, the standard data allowance of 30GB will be increased to 90GB per month (the "**Promotional Price**") for 3 consecutive months on the Eligible Plan.
