

TERMS AND CONDITIONS

FOR

Promotional Offer of 50% discount saving for 12 months to three friends or family members of Superdrug Staff Members only

(Valid between 25 June 2024 – 31 August 2024)

- 1. **Promoter**: Superdrug Head Office, trading as Superdrug Mobile, (company no. 00807043) registered at 51 Sydenham Road, Croydon, Surrey, CRO 2EU, United Kingdom.
- 2. **Promotional Offer**: Superdrug Mobile employees will receive 50% discount code (the "**Promotional Code**") which (i) they can share with 3 friends and family members, and (ii) will be applicable to their respective monthly bills for 12 consecutive months (the "**Promotional Offer**") on either the Superdrug Mobile 30GB data plan or the unlimited data plan (each an "**Eligible Plan**") purchased within the Promotional Period.
- 3. **Dates**: The Promotional Offer will run from 00:00 GMT 25 June 2024 23:59 GMT 31 August 2024 (the "**Promotional Period**"), but may be withdrawn, amended or extended, at any time and without notice (see Section 15 below regarding variations to these terms and conditions).
- 4. To be eligible for this Promotional Offer, you must be an employee of Superdrug Stores plc based in the Superdrug head office Croydon ("Eligible Customers").
- 5. You will receive the Promotional Code via Superdrug internal communication or flyers/announcements at the Superdrug head office in Croydon on or after 24 June 2024 which may be used by three of your friends and family members to redeem the Promotional Offer. You may (i) use the Promotional Code yourself and share it with 2 members of your friends and family; or (ii) just share it with 3 members of your friends and family.
- 6. The Promotional Offer can be redeemed when purchasing the Eligible Plan online on Superdrug Mobile's website at <u>Superdrugmobile.com</u> by applying the Promotional Code during the Promotional Period.
- 7. You must comply with the Terms and Conditions for using Superdrug Mobile (https://www.superdrugmobile.com/register/terms) and follow the promotion steps set out in these terms and conditions.
- 8. The Promotional Offer is available for a maximum of 12 consecutive months on the chosen Eligible Plan. To receive the Promotional Offer for a maximum of 12 months, following purchase and SIM activation, Eligible Customers (and their respective friends and family members) must:
